\*Defined as staff who perform adoption-related social service functions that require the application of clinical skills and judgment (home studies, child background studies, counseling, parent preparation, postplacement, and other similar services).

- \*\*Exemptions from these element are based on
- 1) the social service staff is qualified under the provisions of the IAA regulations, specifically
  - (a) a master's degree from an accredited program of social work or in another human service field; or
- (b) a bachelor's degree from an accredited program of social work; or a combination of a bachelor's degree in any field and prior experience in family and children's services, adoption, or intercountry adoption; and
- (c) are supervised by an employee of the agency who has a master's degree from an accredited program of social work or in a related human service field; and
- 2) the social service staff has completed 12 international home studies where the home studies
  - a. involve face-to-face interviews with household members, and
  - b. an evaluation of the prospective adoptive parents' suitability to adopt.

\*\*\*As of December 2007, it is anticipated that all IFS social service staff will meet the requirements for exemption. Further materials will be added to the training and to this report as needed.
